



Fairgrounds Outside Layout

2019 Dixie Classic Fair Vendor Information

Vendors must provide a self-contained trailer or structure of a permanent nature with hot water and handwashing facilities and meet all Forsyth County Health Department requirements. Vendor must submit an application, picture of concession, preferably in color, and list of items requested to be sold in order to be considered for space. DO NOT INCLUDE HOT DOGS OR HAMBURGERS AS PRODUCT TO BE SOLD. COMMUNITY FOOD BOOTHS HAVE AN EXCLUSIVE ON THESE ITEMS.

Applications for space will be considered, and if space is available and product suitable, contracts will be mailed. Fifty percent (50%) non-refundable deposit is required upon signing of contract. CONTRACT BALANCE IS DUE BY SEPTEMBER 1, 2019. SPACE WILL NOT BE GUARANTEED UNLESS FULL PAYMENT IS MADE BY SEPTEMBER 1, 2019. COMPANY CHECKS OR PERSONAL CHECKS WILL NOT BE ACCEPTED AFTER SEPTEMBER 1, 2019. ONLY CERTIFIED CHECKS, MONEY ORDERS CREDIT CARD OR CASH WILL BE ACCEPTED. A 15% LATE PENALTY ON BALANCE DUE WILL APPLY FOR ALL PAYMENTS AFTER SEPTEMBER 1, 2019.

CAMPING

No reservations are accepted. Camping during fair dates must be arranged upon arrival with the designated person in charge of campground. Water is available at most locations. Vendor is responsible for approved disposal of wastewater. There are 171 camper spaces with full hookups available during the Fair and a limited number with electricity and water only. All campers and sleeping units (trucks, tents, etc.) will be charged a minimum of \$360 per camping unit for Dixie Classic Fair dates, plus \$30/night per camping unit for each night on grounds prior to or after official days of the Dixie Classic Fair. All campers must be off Fairgrounds by October 14, 2019, unless previously approved arrangements have been made with the Administrative Office. (PRICES SUBJECT TO CHANGE).

FARM MACHINERY

Each minimum 20' x 20' exhibit space is \$400. Additional footage will be \$50 per foot..

INSIDE SPACE

Booths are 10' deep x 10' wide. Rates are as follows:

Standard Booth - \$550

Food - \$550 or 18% of gross receipts, (percentage is figured on actual size of trailer/stand) whichever is greater.

Novelties/Jewelry - \$700

Corner booths are \$50 additional for each space.

Non-Profit Booth (must provide documentation stating exemption per section 501(c3) - \$450

OUTSIDE PROMOTIONAL/NOVELTY/ JEWELRY SPACE

Applications for space for these exhibits or displays will be considered, based on product and availability, by the Fair Management.

<u>Standard</u> - \$1000 for 20' minimum, \$50 per foot there after. <u>Jewelry/Novelty</u> - \$1200 for 20' minimum, \$60 per foot there after. <u>Food</u> - \$50 per front foot (10' minimum) or (18%) of gross receipts, (percentage is figured on actual size of trailer/stand) whichever is greater.

Additional footage - \$50 per foot. All corner locations \$50 more. Electrical - (20) amp - \$100, (30/50) amp - \$180, per cord. Vendors are encouraged to use LED lighting. Electrical can be supplemented with generator power.

COMMUNITY FOOD BOOTHS (Non Profit Only)

There are 14 permanent community food booths on the Fairgrounds which are operated by local churches, fraternal and civic organizations. No other space selling hot dogs or hamburgers is allowed. Please see the Community Food Booth application for rules, rates and regulations. Please contact for more information.

OUTSIDE FOOD CONCESSION SPACE

The Fair will consider booking a few concessions selling unique specialty food items. We do not need additional cotton candy, funnel cakes, elephant ears, pizza, turkey legs, popcorn, sausage, fried dough, lemonade stands, ribbon fries, steak and cheese or corn dogs. Space for food concessions: \$50 per front foot with a minimum of ten (10) feet or eighteen percent (18%) of gross receipts, (percentage is figured on actual size of trailer/stand)whichever is greater. Additional footage sold by foot. Electrical charge for each concession cord is \$100 for 20 amp service or \$180 for 30/50 amp. All corner locations will be charged an additional \$50. (PRICES SUBJECT TO CHANGE.)

PRODUCT LIABILITY INSURANCE

Product liability insurance is required with bodily injury limits of \$1,000,000 each occurrence and property damage limits of \$500,000 each occurrence. The Fair must be furnished with a Certificate of Insurance from a company licensed to do business in NC, reflecting the foregoing coverage and the Dixie Classic Fair, City of Winston-Salem must be listed on the certificate as additional insured prior to your arrival. All golf carts, atv's, etc. will require a paid permit and evidence of insurance. Please notify us immediately of lapses or cancellation.

OPERATING HOURS

Lessee agrees to open and operate stand or booth during all operating hours of the Fair.
